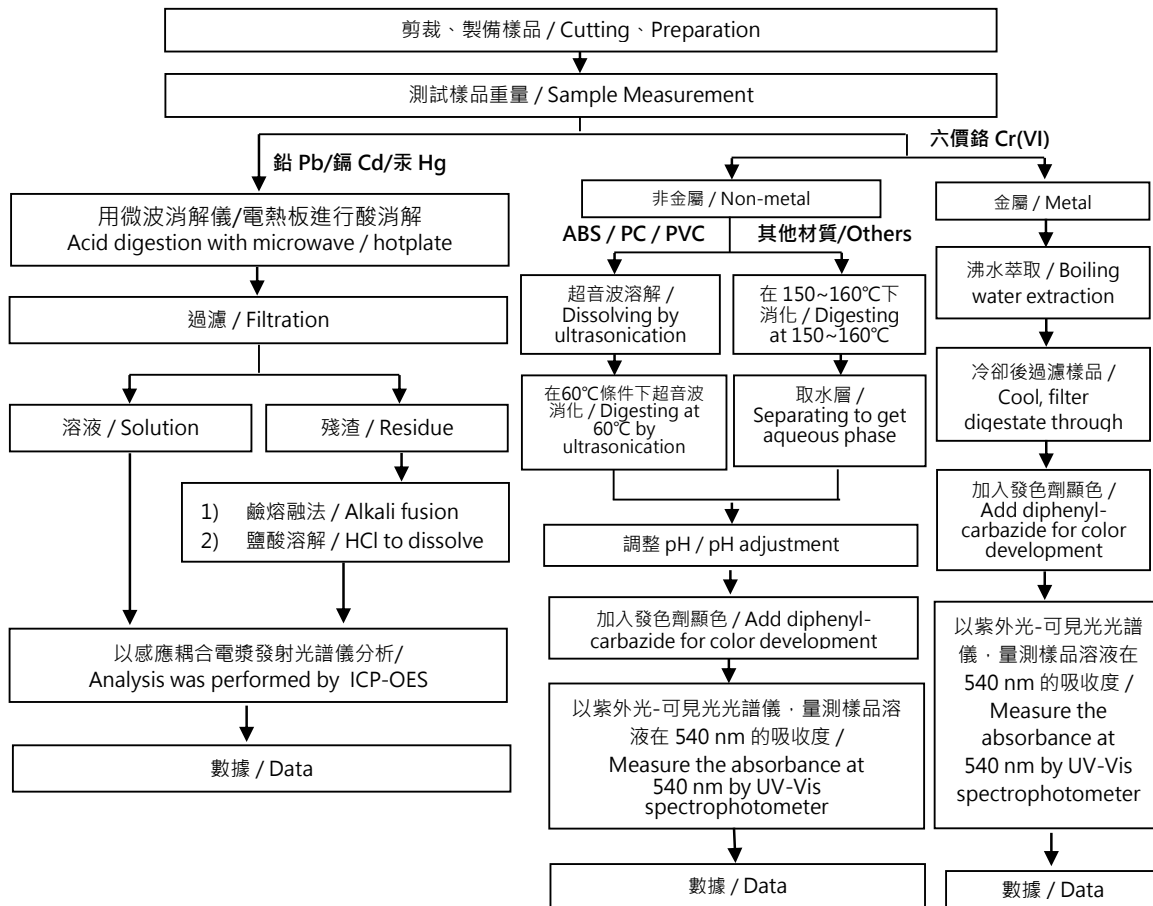

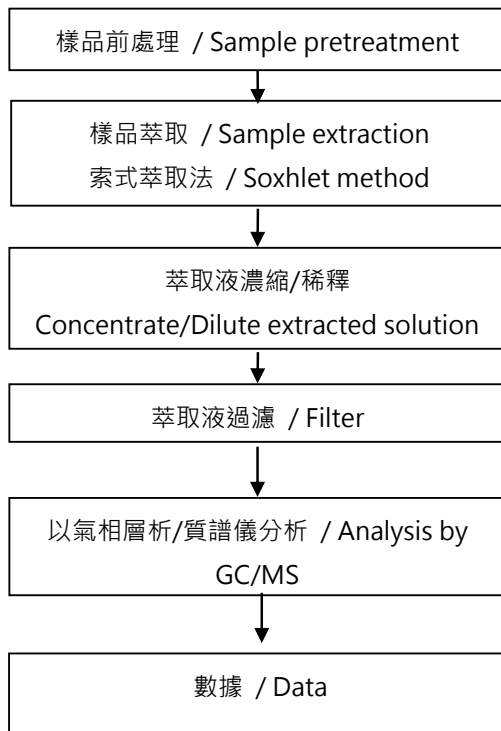

## 多溴聯苯/多溴聯苯醚 分析流程圖 / PBB/PBDE analytical FLOW CHART



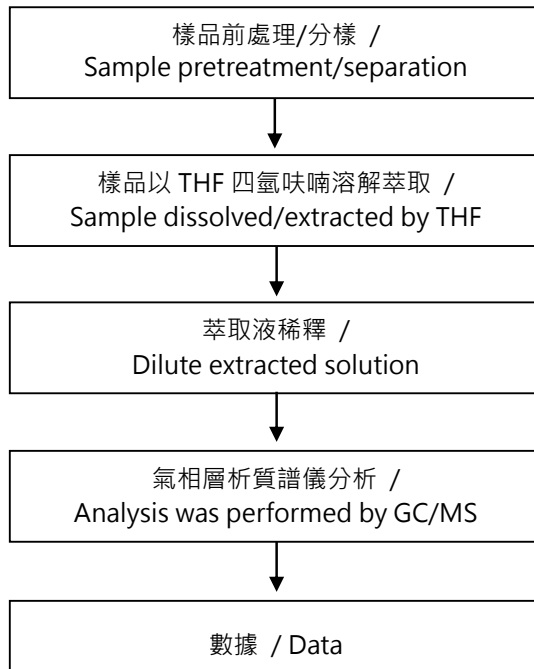

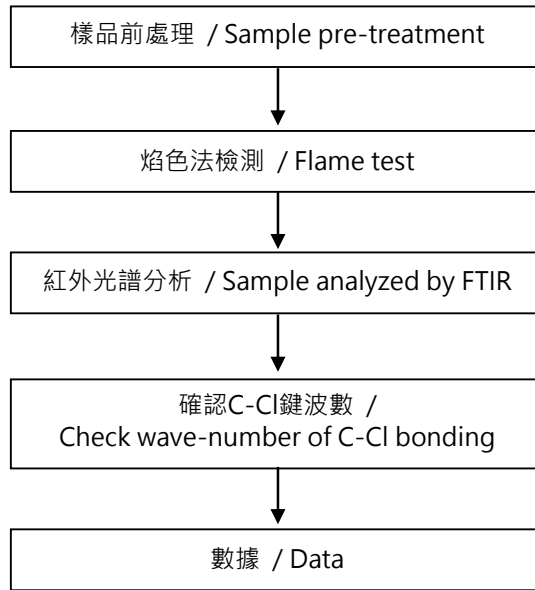

### 聚氯乙烯物質判定分析流程圖 / Analysis flow chart - PVC



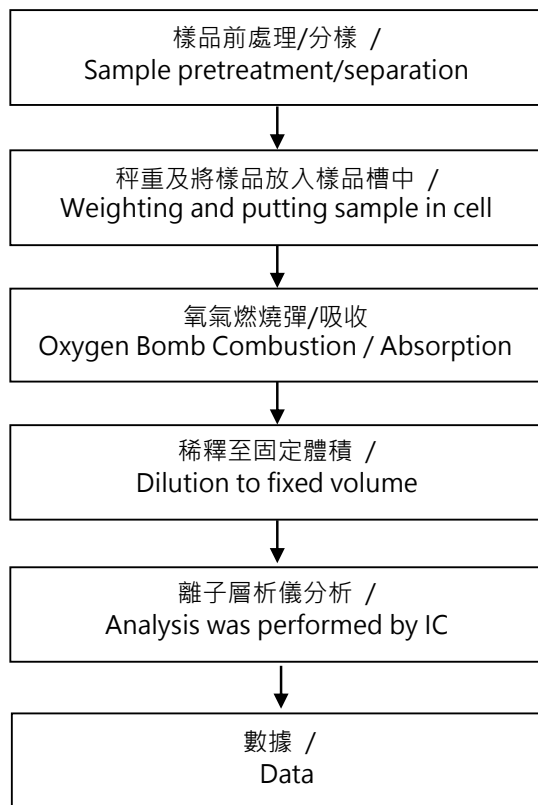
